### **June 2000 to June 2001: Harts Australasia Limited**

Noe Vicca managed the Business Services Division of Harts Australasia Limited, a Public Company in Brisbane's CBD. This division consistently delivered the highest profit return per professional employee for the Public Company. The Business Services Division had in excess of 50 staff who reported directly to Noe Vicca.

### **1999 Goods and Services Tax Legislation**

Prior to the onset of the Goods and Services Tax Legislation in June 2000, Noe Vicca delivered GST seminars on behalf of the Institute's Small Practice Committee and the Queensland State Government. In early 2000 Noe Vicca published a 3 volume GST Practitioner Implementation manual with a fully interactive CD option. The manual was marketed and sold Australia wide to Accounting and Taxation practices.

Noe Vicca established Vicca Milligan Chartered Accountants and in March 1996, Noe took over the practice as a sole practitioner, keeping the name of Vicca Milligan. He continued operating this practice until June 2000. At its peak the practice employed in excess of 20 staff and represented clients operating in multiple international jurisdictions.

Noe Vicca returned to Brisbane from the Sunshine Coast and established Noe Vicca and Associates CPA.

**March 1981: Poole and Vicca**

Noe Vicca relocated from Brisbane to the Sunshine Coast and established a successful CPA practice 'Poole and Vicca'. This practice still operates today under the name of 'Poole and Partners'.
